<p><i>Response: General Manager advised - yes Council has an obligation and requirement to do so</i></p>

<p><i>Response: General manager advised - low key use with possible rental income, once other libraries in the WLGA are completed will revisit the site for future development, looking at a precinct rather than just the site.</i></p>

<ul style="list-style-type: none"> • Consideration of children crossing the road as the road is extremely busy

<ul style="list-style-type: none"> • Very busy road with speeding cars , can the speed limit be reduced to 50km ph

<p><i>Response: GM advised should be open in second half of this year</i></p>

Access	
<ul style="list-style-type: none"> • Access to the relocated library can be difficult for those on the other side of the rail line there are several hills to contend with if walking. How will this impact on elderly users? Needs to be a plan to encourage people to walk to the library.

<p><i>Response: Council's current fees and charges in regards to community facilities applies</i></p>	
<ul style="list-style-type: none"> • Comments made from the audience were that the community sees the railway corridor as 	

a contentious issue if Rail Corp look to develop or widen the line at Artarmon station without any consultation with the community.
